DESCRIPTION

The RA07M1317M is a 6.5-watt RF MOSFET Amplifier Module for 7.2-volt portable radios that operate in the 135- to 175-MHz range.

The battery can be connected directly to the drain of the enhancement-mode MOSFET transistors. Without the gate voltage (V_{GG} =0V), only a small leakage current flows into the drain and the RF input signal attenuates up to 60 dB. The output power and drain current increase as the gate voltage increases. With a gate voltage around 2.5V (minimum), output power and drain current increases substantially. The nominal output power becomes available at 3V (typical) and 3.5V (maximum). At V_{GG} =3.5V, the typical gate current is 1 mA.

This module is designed for non-linear FM modulation, but may also be used for linear modulation by setting the drain quiescent current with the gate voltage and controlling the output power with the input power.




DRAIN CURRENT IDD (A)

OUTLINE DRAWING (mm)






- ① RF Input (P_{in})

RECOMMENDATIONS, and APPLICATION INFORMATION:

Construction:

This module consists of an alumina substrate soldered onto a copper flange. For mechanical protection, a plastic cap is attached with silicone. The MOSFET transistor chips are die bonded onto metal, wire bonded to the substrate, and coated with resin. Lines on the substrate (eventually inductors), chip capacitors, and resistors form the bias and matching circuits. Wire leads soldered onto the alumina substrate provide the DC and RF connection. Following conditions must be avoided:

a) Bending forces on the alumina substrate (for example, by driving screws or from fast thermal changes)

- b) Mechanical stress on the wire leads (for example, by first soldering then driving screws or by thermal expansion)
- c) Defluxing solvents reacting with the resin coating on the MOSFET chips (for example, Trichlorethylene)
- d) Frequent on/off switching that causes thermal expansion of the resin
- e) ESD, surge, overvoltage in combination with load VSWR, and oscillation

ESD:

This MOSFET module is sensitive to ESD voltages down to 1000V. Appropriate ESD precautions are required.

Mounting:

Heat sink flatness must be less than 50 μ m (a heat sink that is not flat or particles between module and heat sink may cause the ceramic substrate in the module to crack by bending forces, either immediately when driving screws or later when thermal expansion forces are added).

A thermal compound between module and heat sink is recommended for low thermal contact resistance and to reduce the bending stress on the ceramic substrate caused by the temperature difference to the heat sink. The module must first be screwed to the heat sink, then the leads can be soldered to the printed circuit board. M2.6 screws are recommended with a tightening torque of 1.8 to 3.0kgf-cm.

Soldering and Defluxing:

This module is designed for manual soldering.

The lead (terminal) must be soldered after the module is screwed onto the heat sink.

The temperature of the lead (terminal) soldering should be lower than 350°C and shorter than 3 second. Ethyl Alcohol is recommend for removing flux. Trichloroethylene solvents must not be used (they may cause bubbles in the coating of the transistor chips which can lift off the bond wires).

Thermal Design of the Heat Sink:

At Pout=6.5W, VDD=7.2V and Pin=20mW each stage transistor operating conditions are:

The channel temperatures of each stage transistor $T_{ch} = T_{case} + (V_{DD} \times I_{DD} - P_{out} + P_{in}) \times R_{th(ch-case)}$ are:

 $T_{ch1} = T_{case} + (7.2V \times 0.40A - 1.5W + 0.02W) \times 4.0^{\circ}C/W = T_{case} + 5.6^{\circ}C$

 $T_{ch2} = T_{case} + (7.2V \times 1.60A - 6.5W + 1.5W) \times 2.4^{\circ}C/W = T_{case} + 15.6^{\circ}C$

For long-term reliability, it is best to keep the module case temperature (T_{case}) below 90°C. For an ambient temperature T_{air} =60°C and P_{out} =6.5W, the required thermal resistance $R_{th (case-air)} = (T_{case} - T_{air}) / ((P_{out} / \eta_T) - P_{out} + P_{in})$ of the heat sink, including the contact resistance, is:

 $R_{th(case-air)} = (90^{\circ}C - 60^{\circ}C) / (6.5W/45\% - 6.5W + 0.02W) = 3.77 ^{\circ}C/W$

When mounting the module with the thermal resistance of 3.77 °C/W, the channel temperature of each stage transistor is:

 $T_{ch1} = T_{air} + 35.6 \ ^{\circ}C$ $T_{ch2} = T_{air} + 45.6 \ ^{\circ}C$

The 175°C maximum rating for the channel temperature ensures application under derated conditions.

Output Power Control:

Depending on linearity, the following two methods are recommended to control the output power:

a) Non-linear FM modulation:

By the gate voltage (V_{GG}). When the gate voltage is close to zero, the RF input signal is attenuated up to 60 dB and only a small leakage current flows from the battery into the drain.

Around V_{GG} =2.5V, the output power and drain current increases substantially.

Around V_{GG} =3.0V (typical) to V_{GG} =3.5V (maximum), the nominal output power becomes available. b) Linear AM modulation:

By RF input power P_{in}. The gate voltage is used to set the drain's quiescent current for the required linearity.

Oscillation:

To test RF characteristics, this module is put on a fixture with two bias decoupling capacitors each on gate and drain, a 4.700 pF chip capacitor, located close to the module, and a 22 μ F (or more) electrolytic capacitor. When an amplifier circuit around this module shows oscillation, the following may be checked:

a) Do the bias decoupling capacitors have a low inductance pass to the case of the module?

- b) Is the load impedance $Z_1 = 50\Omega$?
- c) Is the source impedance $Z_G=50\Omega$?
